Clinical Consultations

In past seven years have conducted approximately 1000 clinical consultations across Canada with patients, families and healthcare teams on a variety of different issues, for example: COVID-19, Do Not Resuscitate, end of life care, narcotic sedation, palliative care, community treatment orders, treatment of women post rape, early induction for fetal anomalies, confidentiality breaches, substitute decision making, informed consent, duty to care and pandemics, etc. etc. Many of these consultations involved writing clinical opinions/reports on particular patient issues. Approximately 60 % of these consultations took place in acute care in large quaternary hospitals (ICU, ER,) 40% took place in community hospitals.
