# APA STYLE, 7<sup>TH</sup> EDITION CITATIONS AND REFERENCES: EXAMPLES OF COMMON SOURCES

This handout is a **summary** of current APA citation guidelines. With it, we aim to answer the questions most frequently asked by Saint Paul University students. We have also included examples of the types of sources most used by students. However, this handout cannot address all citation matters, and in no way does it replace the guidance provided in the Publication Manual of the American Psychological Association, 7th ed. For further examples and more comprehensive explanations, please consult the guidelines in the Manual or on the APA website.

General format of in-text citations is as follows: (last name of author, year of publication). You can also use the author's name in your sentence, immediately followed by the year of publication in parentheses. Examples of both types of in-text citations are provided throughout this handout.

Example: (Lowery & Burrow, 2019) or Lowery and Burrow (2019)

For direct quotations, add the page number after the year of publication: (Gagné, 2020, p. 19)

## **Important notes**

- Each in-text citation must have a **corresponding reference list entry**.
- Place the section label **References** centered and in bold at the top of a new page.
- Arrange the reference list entries in **alphabetical order** by author.
- Reference list entries have a **hanging indent** of 0.5 in. (i.e., the first line is flush with the left margin; all subsequent lines are indented 0.5 in from the left margin).
- **Double-space** the reference list (within and between entries).
- If no publication date is provided, write "n.d." (for "no date") in place of the year.
- A **DOI** is **preferable** to a URL. If a source has both, include only the DOI; a URL is acceptable when no DOI is provided.
- If a source has **three or more authors** (up to 20):
  - o In the citation: Name the first author only and use "et al."
  - o In the reference: Name all authors.
- In the reference list, titles of articles, chapters, books, webpages, and reports are capitalized using sentence case. This means that:
  - Most words are lowercase.
  - You capitalize only the following: the first word of the title; the first word of a subtitle; the first word after a colon or em dash; proper nouns.
  - Since titles are generally capitalized using title case (where most major words are capitalized), you will have to change this manually. If using a citation tool, always doublecheck the capitalization of titles.
    - Notice that the names of periodicals (journals, newspapers, magazines, blogs) are exempted from this; they are capitalized using title case. Use the name as it appears on the source; do not make changes.

#### **JOURNAL ARTICLE**

- **DOI** is preferred whenever available (see first example).
- If the article does not provide a DOI but does have a URL that is not part of a database (e.g., is from the journal's website), include it at the end of the reference (see second example).
- If the article is from an academic research database (JSTOR, Project Muse, ATLA, PsycINFO, PubMed, CAIRN, etc.) but does not have a DOI: end the reference after the page range; do not include a URL or the database name (see third example).
- If the journal article has an article number instead of a page range, include the word "Article" and then the article number where you would normally put the page range (see fourth example).

• There is a wide variety of government publications and reports, and it is impossible to provide examples for all of them here. We are showing you two common examples, but it is possible that your source will not fall into either of those categories.

• If that's the case, try either combining them to include as many elements as possible or finding a similar example elsewhere before adapting it by adding or removing elements as you see fit.

# **RELIGIOUS WORK**

• Religious works are usually treated as having no author.

- The original date of publication of religious and classical works is often unknown or difficult to obtain. Include it only if it is clearly indicated in the version you consulted; otherwise, omit it (see examples below).
- There is a wide variety of religious works, and it is impossible to provide examples for all of them here. Therefore, while we are including examples of common religious works and typical reference components, it is possible that your source will not fit perfectly into any of these categories.
  - If that is the case, either try combining them to include as many components as possible or finding a similar example elsewhere and adapting it by adding or removing components as you see fit.
  - o If still in doubt, go back to the basics: a print bible is a book, and an online version is a webpage. You can find examples of these elsewhere in this handout.

#### **Church or papal document or speech (online)**

- Use the name as it appears on the source. In our example, the author is simply Francis; you may add "Pope" only if you are working the author's name into your sentence. Do not add it to the parenthetical citation or the reference.
- Notice the use of **reverse italics** in the title of the document. Because the title of the document in the reference should be in italics and the Latin words are **already italicized** in the original title of the document, they should be set in standard type in the reference.

#### **CONFERENCE PROCEEDINGS**

Conference proceedings are the published collection—or record—of communications (papers, abstracts, posters, etc.) from a specific conference, symposium, etc. They can be published in a periodical (see example below), but they can also be published as books or book chapters, in which cases you can follow the corresponding examples provided earlier in this handout.

• When conference proceedings are published in a journal, each individual proceeding is akin to a journal article and is cited and referenced as such, as in our example.
