

MLA STYLE, 9TH EDITION: CITATIONS AND REFERENCES

This handout is a **summary** of current MLA Style citation guidelines. With it, we aim to answer the questions most frequently asked by Saint Paul University students. We have also included examples of the types of sources most used by students. However, this handout cannot address all citation matters. For further examples and more comprehensive explanations, please consult the resources listed at the end of the document.

A handout summarizing MLA's main **paper formatting guidelines** (font, spacing, margins, page numbers, footnotes, title page, etc.) is also available on the Writing Centre's [webpage](#) and in the [Citation Style Research Guide](#).

General format of in-text citations is as follows: (last name of author page number); note the absence of punctuation between the two elements. You can also use the author's name in your sentence, immediately followed by the page number in parentheses. Examples of both types of in-text citations are provided throughout this handout.

Example: (Lowery and Burrow 341) *or* Lowery and Burrow (341)

Important notes

- **Each** in-text citation must have a **corresponding entry** in the Works Cited section.
- Whenever a precise date is required (day month year) in a works-cited-list entry, **abbreviate the names of months** that are longer than four letters.
- The **date of access of an online source is optional, except** when the source's publication date is unavailable or unclear. In that case, include it at the end of the entry. Ex.: Accessed 23 Nov. 2019.
- For online works, a DOI, if provided, is preferred to a URL.
 - If providing a DOI, add <https://doi.org/> before the string of numbers if it is not already there.
 - If providing a URL, omit the <https://> or <http://>.
- If a source has **more than one author**, use the examples provided under "Book" and then combine with the appropriate document type format.
 - If a source has **two authors**, pay attention to the order of first and last names in the works-cited-list entry: Last name, first name of first author and first name and last name of second author. (See example below.)
 - If a source has **three or more authors**, name the first author only, followed with "et al." This applies to both in-text citations and works-cited-list entries. (See example below.)
- If the source has **no explicit page numbers**:
 - Include paragraph numbers **if provided**: (Nguyen, par. 8)
 - Include chapters or section headings if provided: (Nguyen, ch. 3) *or* (Nguyen, sec. "Background")
 - Include line numbers if provided: (Nguyen, line 31)
 - Omit altogether if no other obvious subdivision is provided: (Nguyen)

NEWSPAPER, MAGAZINE, OR NEWS WEBSITE ARTICLE

Use this format for articles from newspaper websites (*Ottawa Citizen*, *The New York Times*, *The Globe and Mail*, *La Presse*, *Le Droit*, *Le Devoir*, *The Guardian*, etc.), news websites (*CBC News*, *HuffPost*, *Radio-Canada*, *CNN*, *BBC News*, etc.), and online magazines (*The Atlantic*, *Macleans*, *L'actualité*, *Psychology Today*, etc.).

This type of article generally doesn't have explicit page numbers; you can omit this element of the in-text citation (see example).

BLOG POST

Blog posts generally don't have explicit page numbers; you can omit this element of the in-text citation (see example).

GOVERNMENT PUBLICATION OR REPORT

When a document is published by an agency or organization that is also its author, begin the entry with the title of the document followed by the name of the agency or organization (see first example below).

No individual author (agency or department as author)

WEBPAGE (general, institutional, corporate, etc.)

- Webpages on institutional or organizational websites generally don't have individual authors. The works-cited-list entry must therefore begin with the title of the webpage, followed by the name of the organization or institution (see the two examples below).
 - If a webpage does have an author, follow the examples for newspaper, news website, or magazine articles or blog posts.
- If a webpage does not have a publication date, provide the copyright date (©), usually found at the very bottom of the page.
 - Only in very rare instances will webpages have neither publication nor copyright date; in this case, you must include the access date at the end of the entry.
- Webpages don't have explicit page numbers; you can omit this element of the in-text citation.

COURSE LECTURE OR POWERPOINT SLIDES

The *MLA Handbook* does not address the citing of course material. Below is our suggestion, which we have created using various citation guides.

Components of works-cited-list entry	Last Name, First Name of Author. "Title of Lecture or Presentation." Course code: Course Name, day month year of lecture, University Name, Platform URL if content was accessed online. Type of document or presentation.
Example of works-cited-list entry	Lafrenière, Geneviève. "Conflict studies in the 21 st century." ECS 2561: Introduction to Conflict Studies, 18 Jan. 2026, Saint Paul University, www.uottawa.brightspace.com . PowerPoint slides.

SOCIAL MEDIA CONTENT

- If a creator's online handle (@) is similar to their account name (for example, @eltonjohn and Elton John), you can omit their handle; otherwise, supply the handle in square brackets after their name.
- With this type of source, **the title of the post is the text of the post**.
 - If it is short (a sentence or two), provide it in its entirety

- If it is long, shorten it using an ellipsis (“...”) after the first few words.

YOUTUBE, VIMEO, OR OTHER ONLINE VIDEO

The *MLA Handbook* does not give explicit guidelines on how to cite a video from a video sharing site. Here are our suggestions, which we have created using various citation guides.

If the creator of the video is known/identifiable

Components of works-cited-list entry	Last Name, First Name of Creator. "Title of Video." <i>Platform/Site Name</i> , uploaded by Username if different than creator, day month year of publication, URL.
